

Business Reserve Account

A straightforward way to manage your business savings

This leaflet sets out the key information you need to know about your account. It should be read together with the *Business account terms* and *Credit Interest Rates*. Please keep it for future reference.

	Interest is calculated daily and paid on the last business day of the month and at account closure. You'll be able to see and access the interest in your account on the following business day.		
Can NatWest change the interest rate?	Yes, this rate is variable. We can increase or decrease the rate for the reasons set out in the <i>Business account terms</i> . If the rate is going down, we'll give you at least 60 days' notice. If it is going up, we'll give you notice either before the change happens or as soon as possible afterwards. Please see General Terms 11.1 and 11.3 of the <i>Business account terms</i> for more details on when we may change the interest rates and the notice we'll give you.

How do I open and manage the account?	You can open and manage your account in branch, online and by telephone. There is no minimum deposit required to open the account, and there is no maximum balance limit.		
Can I withdraw money from the account?	Yes. No notice is required. You can withdraw money: <ul style="list-style-type: none">• in branch;• by transfer to your business current account at NatWest (in branch, online, by telephone or on the mobile app);• by transfer to any other account based in the UK (online, by telephone or on the mobile app).
